XUQUUQDA AY LEEYIHIIN DHIBBANAYAASHA XADGUDUBKA GURIGA RIGHTS FOR DOMESTIC VIOLENCE VICTIMS

1. Waxa aad weydiisan karta dawladda hoose ama xeer ilaaliyaha degmada xaraynta dacwad ciqaabeed.
2. Waxaa kale oo xaq u leedahay in aad maxkamadda tagto iyo xarayso dacwad aad ku codsanayso Amarka Ilaalinta xadgudubka guriga. Amarka waxaa ku jiri kara waxaa soo socda:
 - a. amarka ah in xadgudubuhu aannu la imaan xadgudub dambe;
 - b. amarka ku waajahan in xadgudubuhu uu isaga tago gurigaadaan;
 - c. amarka looga ilaalinayo in xadgudubluhu soo galo gurigaada (ama goob macquula ee agagaarka gurgada), dugsiga, ganacsiga ama gobta shaqada;
 - d. amarka laguugu bixinayo haynta waalidnimada/ama booqashada canugga yar ama caruurta; ama
 - e. amarka ku waajahan xadgudublaha ee ku saabsan bixinta masruufka ilmaha haddii xadgudubuhu maxkamaddu sidaan ku amartay.

CLAIMS MUST BE FILED WITHIN THREE YEARS OF THE CRIME DATE, EXCEPT CASES INVOLVING CHILD ABUSE. SOME EXCEPTIONS APPLY.
