

Parks and Natural Resources 2025 Annual Work Plan

City Code 2-2-1: Purpose

The Parks and Natural Resources Commission is an advisory body to the City Council. The mission of the Parks and Natural Resources Commission is:

- 1) To advise the City Council and staff on parks and natural resources issues.
- 2) To guide the development, improvement, renovation and management of our park system.
- 3) To advocate the responsible use, preservation and enhancement of our natural resources.

The Commission is responsible for the following specific duties related to the accomplishment of the mission:

- 1) Preparing and recommending updates to the parks master plan and the natural resources master plan to the City Council.
- 2) Providing a forum for citizen input.
- 3) Reviewing City policies, regulations and plans as relevant to the nature of the Commission.
- 4) Involvement with the development review process as appropriate. (Ord. 802, 7-17-2000)

Regularly scheduled meetings:

On an annual basis the Parks and Natural Resources Commission establishes a work plan for the upcoming year. The commission adopts the work plan in January of each year. The PNRC Chair presents the work plan to Council for their feedback and approval in February.

For items to be placed on a regularly scheduled PNRC meeting items must fall into one of the categories below. All other items may require approval by a Department Director, the Leadership Team, Deputy City Manager or City Manager.
